Court Hearing Results under Section 2 of The Dogs Act 1871

Thursday 28th June 2018 at Chelmsford Magistrates Court, Stella Betts, age 61 of Highfields, Great Yeldham for being the owner of 2 Staffordshire Bull Terrier type dogs that were dangerously out of control in Beazley End on 29th September 2017. The dogs attacked a Jack Russell Terrier resulting in injuries being sustained and the dog being put to sleep by a vet. Mrs Betts was unable to attend the hearing, but contacted the Court and admitted her dogs were dangerously out of control. The Magistrates put a control order on the two dogs and ordered Mrs Betts to pay costs of £854.50.

Successful prosecutions for Braintree District Council for Fly-Tipping

Braintree District Council was successful in taking legal action against the following people for fly-tipping and associated offences last week under the Environmental Protection Act 1990.

Donna Loveridge, age 31 from Ridgewell for the unauthorised deposit of waste in a by-way in Ridgewell. The waste had been collected for payment from a property in Cavendish. Miss Loveridge was prosecuted for fly tipping and failure provide receipts for the collection and deposit of the waste collected from Cavendish. This case was heard at Chelmsford Magistrates Court on 20th June 2018. Miss Loveridge pleaded guilty to the offences and was fined £320, ordered to pay costs of £561 and pay a victim surcharge.

Gavin Cooper, age unknown from Beazley End for the unauthorised deposit of waste in an un-named road between Halstead Road and Whiteash Green. This was a large amount of waste which partially obstructed the road. This case was heard at Chelmsford Crown Court on 21st June 2018. Mr Cooper pleaded guilty to the offence and was fined £500, ordered to pay costs of £1084 and pay a victim surcharge.

Thomas England, age 26 from Writtle for the unauthorised deposit and disposal of waste which included asbestos, at a property in Glebe Crescent, Witham. Mr England pleaded guilty to the offences in a hearing at Chelmsford Magistrates Court but was referred to the Chelmsford Crown Court on 21st June for sentencing. Mr England was sentenced to 15 months custody, suspended for two years, was ordered to undertake 250 hours of unpaid work within 12 months and pay costs of £1000. An order for forfeiture of the vehicle used in commission of the offence was given.

Councillor Wendy Schmitt, Cabinet Member for Environment and Place, said: "Fly-tipping is simply not acceptable – it not only harms the environment and looks unsightly, but it costs the taxpayer to clear it up. We need the public to understand their rubbish is their responsibility and they must dispose of it correctly. I hope successful prosecutions like these send out a clear message that we take fly-tipping extremely seriously and are not afraid to take legal action against those who don't do the right thing with their waste, who ruin our environment and have no respect for others."

Planning inspector confirms housing growth figure for North Essex

A planning inspector has confirmed the amount of new houses which need to be built across north Essex over the next 15 years.

Colchester Borough and Braintree and Tendring District councils submitted a joint section one to their Local Plans, a blueprint for growth in the area until 2033.

Following a public examination of the Local Plan, a planning inspector has now reported back on the expected housing need for the period. He reported back on other aspects within the Local Plan last month.

The inspector backed the councils' submitted figures for housing growth up until 2033 – of 550 new homes each year in Tendring, 716 in Braintree, and 920 in Colchester.

His response on housing figures had been delayed from the rest of the Plan after consideration of a late submission from a developer over Tendring's projected numbers.

However, the inspector ruled the councils had accurately predicted housing need based on national guidelines.

Graham Butland, Leader of Braintree District Council, said "I am pleased that the Planning Inspectorate agrees with the housing need figures which underpin our Local Plan. We know building new homes is a key priority for the Government. Having a Local Plan allows us to shape where these new homes go, and make sure they are built in sustainable places, rather than where best suits developers."

Neil Stock, Leader of Tendring District Council, welcomed the inspector's response. He said: "Getting an accurate figure for predicted housing growth is a critical part of the Local Plan, as it sets out how many new homes we need and how quickly we need them. This will provide greater certainty for housebuilders and councils which can only be a good thing," he said. "I am glad the inspector has recognised the amount of work which has gone into this calculation, and that this can provide reassurance to the public that we have not simply plucked a figure out of the air."

Tim Young, Deputy Leader of Colchester Borough Council, said the borough was at the forefront of delivering sustainable growth. He said: "Colchester continues to be a place where people want to live, work, learn and visit, and that is reflected in our housing figure. Having a strong Local Plan in place, which has been prepared in consultation with our residents, is vital to ensure Colchester's housing requirements deliver sustainable developments in the right places and with the right infrastructure. It is not just about housing numbers, but creating great places where vibrant local communities can thrive and prosper."
