Sturmer Flood Action Group

Here is the update for the meeting next week.

Highways Gullies were cleared on the A1017 and in Water Lane on 5 and 6 November and marked green and blue this year.

We commented on a consultation on surface water drainage asking for more publicity for the role of the County Council as Lead Local Flood Authority and saying that the asset register for drainage will not be useful if SUDs are not installed in accordance with planning permissions as is now being reported.

We received a reply from West Suffolk concerning the reputation of Redrow for not installing SUDs and have been assured this will be monitored by Suffolk County Council and West Suffolk. Sadly, as usual they tell us to contact Essex if we experience any problems with the Great Wilsey development (by Redrow and in their area).
