<u>District Councillor's Report 06<sup>th</sup> August 2019 to Sturmer Parish Council (Cllr. Diana Garrod - Bumpstead Ward)</u>

## Steeple Bumpstead Surgery Update as at 05.08.19

I attended a further meeting in Steeple Bumpstead on 5<sup>th</sup> August. Although Provide still hold the contract, Uttlesford Health is running the surgery and all is going well. The CCG are still in discussion with interested parties and are awaiting a response from a detailed questionnaire. A further meeting is scheduled for early October. The Patient Participation Group will provide information to village newsletters.

## First Neighbourhood Plan adopted

The first Neighbourhood Plan in the Braintree District was formally adopted at a Full Council meeting held on Monday 22<sup>nd</sup> July. The Bradwell with Pattiswick Neighbourhood Plan can now be used when considering planning applications within the parish of Bradwell with Pattiswick.

### **Corporate Customer Satisfaction Survey**

Braintree District Council has published its annual Corporate Customer Satisfaction Survey results which shows satisfaction rates which are significantly higher than the national average. The results for 2018/19 show that 82 per cent of residents are satisfied with the Braintree District as a place to live, 80 per cent of residents are satisfied with the way Braintree District Council runs things, 61 per cent of residents feel that the council offers value for money. The results also show that 71 per cent of residents feel well informed about council services and 77 per cent of residents are satisfied with the way the council keeps the district clear of litter. The results show a 60 per cent satisfaction rate in sports and leisure.

# **Local Plan Update**

A new rapid transit system forms part of Local Plan proposals for three new Garden Communities across North Essex. The council has published evidence they have compiled to answer the Inspector's questions on issues including land for employment, viability, and the environment. This will show that the plans are viable, sustainable and can provide a significant boost to the local economy, offering a wide variety of homes, including a minimum of 30% of homes set aside as affordable housing.



Central to the new evidence are plans for a 'rapid transit' network which would grow alongside North Essex reducing congestion, improving air quality and providing quick and easy access into and out of Colchester and Braintree linking in to other public transport hubs. North Essex Garden Communities Limited (NEGC Ltd) have been working with leading industry consultants and public transport operators to develop the scheme in such a way that the infrastructure is in place so that

it can provide the next generation of public transport for communities in North Essex such as trackless tram schemes. The system will include traffic priority measures (such as segregated routes) and is planned to run every 10 minutes to ensure journey time reliability and frequency of service. Ultimately, the network will develop over time into an east-west public transport corridor running across North Essex, from the Tendring Colchester Border Garden Community located close to the University of Essex, through Colchester town and connecting the Garden Community settlements westwards through to Stansted Airport.
