District Councillor's Report December 2021 to Parish Councils (Cllr. Diana Garrod - Bumpstead Ward)

#### Temporary Traffic Regulation Orders

Intended closure of Water Lane, Helions Bumpstead due to commence on 22<sup>nd</sup> December 2021 for 6 hours. The closure is required whilst Openreach undertakes pole testing.

Intended closure of Kedington Road, Sturmer due to commence on 23rd December 2021 for 5 hours. The closure is required whilst Openreach undertakes pole testing.

#### Local Plan Section 2 is Proposed – Consultation Commences 6th December 2021

Following the Local Plan hearing sessions in July 2021, the Inspectors have now given their feedback and recommended proposed main modifications to the plan before they can find the section 2 local plan sound and has now asked BDC to undertake a 7 week public consultation period starting from Monday 6 December until 5pm on Monday 24 January 2022. The consultation is focused on the main modifications to the Local Plan and an updated Sustainability Appraisal and Habitats Regulation Assessment which have been amended to reflect these modifications. More detail can be found on the website <u>Main Modifications Consultation Dec 2021 - Jan 2022 – Section 2 Examination Local Plan – Braintree District Council</u>. close of the consultation all responses will be published in full online and sent to the Inspector for his consideration. This will allow them to come to a final conclusion on the modifications to the section 2 Local Plan and inform BDC accordingly. <u>Suffolk and Cambridgeshire get extra support to tackle rise in COVID-19 cases.</u> Since the Bumpstead Ward borders Suffolk and Cambridgeshire I felt it worthwhile distributing this information:-

Suffolk, Cambridgeshire and Peterborough will become Enhanced Response Areas for five weeks to help bring down Covid-19 infection rates. The package will enable the local authorities to deliver extra testing, help increase vaccine and testing uptake, and fund local public health campaigns. They will also work with the DfE to see what additional measures can be used in schools. Jyoti Atri, director of public health for Cambridgeshire and Peterborough, said: 'A rising rate of infections particularly in our older population meant I had to make this application now. This increase starting to build in our 60+ age groups, coupled with low vaccination rates in some parts of Cambridgeshire and Peterborough – means pressure is building on our local health services. 'This is exacerbated by increased levels of COVID infections in the general population, and staff being unable to work because they are infected or isolating. If unchecked, this will also impact on health care for other non-COVID needs.' ClIr Richard Howitt, chair of Cambridgeshire County Council's adults and health committee, said: 'Our vital public services – not just the health services, but the education of children in our schools - is starting to be severely affected by the rising rates of infection, with children missing their lessons or schools needing to close classes or even whole year groups because there aren't a safe level of adults present due to isolation. 'The Enhanced status will further enable measures across the whole population that we know can work to slow down infection rates and were working earlier in the year.' <a href="https://www.localgov.co.uk">https://www.localgov.co.uk</a>

The NHS is warning of a new scam inviting people to order an 'Omicron PCR test' or a 'Covid-19 Certificate' and is encouraging councils to share this. The NHS never asks for bank details, so please be aware of suspicious emails or text messages.

#### Funding for Farmers to Boost Productivity

Farmers, foresters and growers are urged to apply for grants to buy new equipment and infrastructure to help to improve efficiency. This could include solar powered electric fences, water treatment systems that use ultraviolet light rather than chemicals and cameras for monitoring livestock. The Farming Investment Fund (FIF) provides grants to improve productivity and bring environmental benefits. FIF is made up of 2 separate funds:

- Farming Equipment and Technology Fund (for grants between £2,000 and £25,000)
- Farming Transformation Fund (for grants between £35,000 and £500,000)

#### Measures to Protect Against Avian Flu

Housing measures to protect poultry and captive birds from avian influenza have come into force. This means that it is a legal requirement for all bird keepers to keep their birds indoors, or where this is not practical, to

take steps to separate them from wild birds. Keeping your birds undercover away from wild birds is vital to minimise the risk of them becoming infected with avian influenza by wild birds. But housing alone is not the only solution – it remains essential that you follow strict biosecurity measures to reduce the risk of disease spreading to your birds.

Council received a message from ECC to encourage all to support local traders and local employment by wherever possible to buy locally and if you are an armchair shopper to use the Click-It-Local to browse online Essex shops and have purchases delivered in one delivery.

Office received an update from Dedham Vale AoNB project works.

County Cllr Peter Schwier advised the following - With the Business Adaptation Grant scheme due to end on 31 December 2021, Essex County Council is urging any small and medium-sized businesses that have yet to bid for funding to apply. Businesses can receive up to £5,000 to adapt how they operate and help to reduce the risk of Covid-19 spreading.

Essex County Council's business grants have proved highly successful, with over £10m of the allocated £14.4m funds being awarded to over 4,000 businesses to date.

SMEs are encouraged to <u>apply through their city</u>, <u>district or borough council</u>, before the funding runs out.

In the run up to Christmas, more businesses, particularly those requiring additional support in the crucial hospitality sector can apply for funding, to invest in seating, shelter, and lighting, to enable outdoor trade.
