APPENDIX B

District Councillor's Report 5th December 2017 – Sturmer Parish Council

Braintree District Council has been recognised for its quality of the district's parks and green spaces at this year's Essex Playing Field Awards. The Council topped their previous achievements and received 38 awards this year which recognises their work in maintaining and protecting the district's playing fields, including 10 gold awards, 15 silver and 13 certificates of merit.

The Essex Lottery, set up by Essex County Council is now up and running. It is based on the principle of raising money within the community for the community. 60p from every £1 ticket sale will go directly to good causes within communities across Essex — more than double the National Lottery. There is zero cost to the charities, projects and groups who choose to take part. The County Council itself does not take a penny from the initiative. I have received a request from a resident in Sturmer to ask 'if a shelter could be considered to accommodate the school children living in Sturmer whilst waiting for their bus in the morning and have a suitable pedestrian crossing to cross heavy traffic on the main road.'

The resident has said: 'At the moment, children and residents from Sturmer are waiting for their bus going towards Haverhill on the verge of the road, at the Sturmer sign. There is hardly any space for people to stand considering the width of the pavement and crossing the road as the bus arrives is too hazardous.'
